The Ninth Ci rcuit Court of Appeals declined to grant the regulator an emergency stay ㈛ 6; of a ruling that allows the deal to proceed in the US. Microsoft first offered Sony a 10-year deal to 🔔 keep Call of Duty on current and future PlayStation consoles at the end of last year, though
